

### **Terms & Conditions**

- 1. The bids are invited through e-procurement, hence offline tenders will not be considered.
- 2. The rates are to be quoted to have a minimum validity for a period upto 90 days and bidder should submit their rates also in the proforma given in scope of work (Annexure-II) with financial bid. The rates are to be quoted with cost and supply of all materials at site i.e. ICAR-CPRI-RS, Modipuram, including all taxes, Service Tax, Transportation of materials and labour charges etc., for each item of work.
- 3. In case of any cutting and over writing it must be counter signed by the tenderer.
- 4. The quality of the material used in the work can be used only after checking of material by the designated officer.
- 5. Performance Security (PS) (Defective Liability Period (DLP): The successful bidder will be required to furnish the Performance Security (PS) in INR equivalent to 3% of the order value within 7 days of receipt of Work Order. The Performance Security (PS) should be submitted in the form of Demand Draft drawn in favour of Senior Scientist, CPRS, Modipuram (State Bank of India, Palhera Branch, Modipuram, IFSC Code. SBIN0003067) or through online mode in Account No. 10172900089, (Senior Scientist, CPRS, Modipuram), State Bank of India, Palhera Branch, Modipuram, IFSC Code. SBIN0003067. The Performance Security (PS) will be retained for a period of one year from the date of the completion of the work.
- 6. Penalty for delayed Completion of the works: The Joint Director, ICAR-CPRI-RS, Modipuram reserves the right to levy penalty @ of 0.5% of order value per week of delay beyond the scheduled date completion/execution of the order successfully, subject to maximum of 10% of the order value. The Joint Director, ICAR-CPRI-RS, Modipuram reserves the right to cancel the order in case the delay in more than 4 weeks.
- 7. After completion of the work if within one year, any defect, or damage or poor workmanship is noticed; the same shall be rectified by the contractor within 10 days failing which performance security shall be forfeited.
- 8. If any damage occurs to ICAR-CPRI-RS, Modipuram property during execution of work including dismantling the same will be borne/ repaired by the tendered. For this reason, the tenderer is advised to inspect the work site before submitting the tender.
- 9. The financial bids will be opened of only those bidder who found technically qualify. The financial bid will be evaluated on the basis of prices quoted. The contract will be awarded to lowest evaluated bidder. No price escalation will be permitted.
- 10. If more than one bidder happens to quote the same lowest price, the firm have been more experience will be awarded the work and if experience of both firm remains same, ICAR-CPRI-RS, Modipuram reserves the right of decide the criteria and further process for awarding the contract, decision of ICAR-CPRI-RS, Modipuram shall be final for awarding the contract.
- 11. At any time prior the deadline for submission of bids. ICAR-CPRI-RS, Modipuram may, for any reason, whether on its own initiative or in response to clarification request by a prospective bidder, modify the bid document.
- 12. The tenderer will be abide by the contract labour act, minimum wages act and other labour related acts, applicable during execution of the work.

- 13. The workers will be personnel of the tenderer and ICAR-CPRI-RS, Modipuram will have no responsibility whatsoever to them. Any liability that may arise due to death/injury to any of the workers while executing the work will be borne by the tenderer.
- 14. Payment will be made after 100% completion of the work on actual measured quantity basis and acceptance by ICAR-CPRI-RS, Modipuram through NEFT/RTGS/e-Payment. The necessary deductions Viz. income Tax, Cess on I.T., TDS on GST, Labour cess, if applicable, and such other taxes levied by government from time to time will be deducted from the work bill.
- 15. No advance or part payment will be made for execution of work
- 16. Form C & D will not be issued by the office.
- 17. The work should be completed on or before 30 days from the date of work order to the satisfaction of the authority concern.
- 18. The contractor should be furnish/enclosed the copy of following documents: scan copy of EMD/Bid Security declaration form (Annexure-I), Scope of work (Annexure-II) and Check List (Annexure-III) valid license of the firm/ contractor, PAN Card/ Aadhar Card, Income Tax return of last three years, GST registration certificate/ GST return Certificate, Experience of having successfully completed similar works during last three years (from Government organization such as CPWD/PWD/autonomous bodies etc.
- 19. In case of any dispute on execution or other issues related to this work, the decision of the Director, ICAR-CPRI, Shimla, will be final and binding on both the party.
