Terms & Conditions

- 1. The bids are invited through e-procurement, hence offline tenders will not be considered.
- 2. Firm should have experience of at least 03 years for construction of similar works (Documentary evidence should be enclosed). During the last 03 years the firm must have completed 2-3 work of the similar nature in Govt/Semi Govt/PSU etc. The Work performed in collaboration or Sublette will also be considered.
- 3. The all rates of structures and all other works must be inclusive for all taxes.
- 4. The tender/bid submitted by the bidder should be valid for a period of 90 days from the date of opening of tender/bid. However, the bidder to whom work will be awarded, their tender/bid will be considered valid till completion of work.
- 5. In case of any cutting and over writing it must be counter signed by the tenderer.
- 6. The agency/firm should not have been banned/black listed earlier by any Ministry/Department/Agency of Government.
- 7. Performance Security (PS) Defective Liability Period (DLP): The successful bidder will be required to furnish the Performance Security (PS) in INR equivalent to 5% of the order value within 7 days of receipt of Work Order. The Performance Security (PS) should be submitted in the form of Demand Draft drawn in favour of CPRIC, Modipuram (State Bank of India, Palhera Branch, Modipuram, IFSC Code. SBIN0003067) or through online mode in Account No. 10172900089, (CPRIC, Modipuram), State Bank of India, Palhera Branch, Modipuram, IFSC Code. SBIN0003067. The Performance Security (PS) will be retained for a period of one year from the date of the completion of the work.
- 8. Penalty for delayed Completion of the works: Head, ICAR-CPRI-RS, Modipuram reserves the right to levy penalty @ of 0.5% of order value per week of delay beyond the scheduled date completion/execution of the order successfully, subject to maximum of 10% of the order value. The Head, ICAR-CPRI-RS, Modipuram reserves the right to cancel the order in case the delay in more than 4 weeks.
- 9. No advance payment will be made. However, the payment will be made 100% completion of the work on actual measured quantity basis and acceptance by ICAR-CPRI-RS, Modipuram through NEFT/RTGS/e-Payment within normally 45 days from the date of receipt of Bill for execution the work in good condition as per order. The necessary deductions Viz. Income Tax, GST-TDS, Labour cess, if applicable, and such other taxes levied by government from time to time will be deducted from the work bill.
- 10. The quantity proposed in the quotation may be increased or decreased upto 25% at the discretion of the authority while placing the order.
- 11. Before quoting rates the bidder may visit the premises where work has to be done and ascertain the condition of the premises and fixtures & fittings. Any additional claim after bidding will not be entertained.
- 12. The bidder does not quote rate of any item under schedule of quantities or left the rate column blank then their bid will be treated as unresponsive & shall not be considered.
- 13. If the Government imposes any new taxes on this concerned nature of work after issuing the work order, then same may be reimbursed to party if they submit the relevant proof of that.

- 14. The workers will be personnel of the tenderer and ICAR-CPRI-RS, Modipuram will have no responsibility whatsoever to them. Any liability that may arise due to death/injury to any of the workers while executing the work will be borne by the tenderer.
- 15. If any damage occurs to ICAR-CPRI-RS, Modipuram property during execution of work including dismantling the same will be borne/ repaired by the tendered. For this reason, the tenderer is strongly advised to inspect the work site before submitting the tender.
- 16. The financial bids will be opened of only those bidder who found technically qualify. The financial bid will be evaluated on the basis of prices quoted. The contract will be awarded to lowest evaluated bidder. No price escalation will be permitted.
- 17. If more than one bidder happens to quote the same lowest price, the firm have more turnover will be awarded the work and if turnover of both firm remains same, ICAR-CPRI-RS, Modipuram reserves the right to decide the criteria and further process for awarding the contract, decision of ICAR-CPRI-RS, Modipuram shall be final for awarding the contract.
- 18. At any time prior the deadline for submission of bids. ICAR-CPRI-RS, Modipuram may, for any reason, whether on its own initiative or in response to clarification request by a prospective bidder, modify the bid document.
- 19. The tenderer will be abide by the contract labour act, minimum wages act and other labour related acts, applicable during execution of the work.
- 20. On the Basis of Technical Feasibility, tender will be accepted.
- 21. Form C & D will not be issued by the office.
- 22. The work should be completed on or before 30 days from the date of work order to the satisfaction of the authority concern.
- 23. For inspection of site Dr. Satish Kumar Luthra, Principal Scientist or Assistant Admin. Officer may please be contacted between 10 am to 4 pm on all working days.
- 24. The contractor should be furnish/enclosed the copy of following documents: scan copy of EMD/Bid Security declaration form (Annexure-I), Scope of work (Annexure –II), Check List (Annexure-III) and declaration (Annexure-IV) valid license/Registration of the firm/ contractor, PAN Card/ Aadhar Card, GST registration certificate/ GST return Certificate, Experience of having successfully completed similar works during last three years (from Government /Semi Government/PSU/Autonomous bodies/ Organizations etc.
- 25. In case of any dispute on execution or other issues related to this work, the decision of the Director, ICAR-CPRI, Shimla, will be final and binding on both the party.
- 26. The Head, ICAR-CPRI-RS, Modipuram reserve the right to reject any or all bids without assigning any reason thereof.
