



नियम और शर्तें / Terms & Conditions:

- 1. The tender/bid document should be put in Tender box kept at room no. 3, Admin. Block, ICAR-CPRI(RS), Opposite SDS Global Hospital, Modipuram, Meerut before the stipulated time on the last day of bid submission.
- 2. Deadline for receipt of tender/bid is 01.00 PM on or before 30.10.2024. Late submission will not be entertained on any account.
- 3. The tender/bid will be opened at the above office at 03.00 PM on 30.10.2024, and authorized representatives of bidders can be present at the time when the tenders/bids are opened. If holiday is declared on the day of opening of tender, then tender will be opened on next working day at the same time.
- 4. The tender/bid submitted by the bidder should be valid for a period of 90 days from the date of opening of tender/bid. However, the bidder to whom work will be awarded, their tender/bid will be considered valid till completion of work.
- 5. The agency/firm should not have been banned/black listed earlier by any Ministry/Department/Agency of Government.
- 6. Following documents/details should be furnish/enclosed by bidder along with tender/bid;
 - a. Scope of work.
 - b. Copy of Valid license/Registration Certificate.
 - c. Scan copy of Bid Security declaration form.
 - d. Profile of firm including name of owner, telephone no./e-mail address.
 - e. Copy of PAN Card/ Aadhar Card.
 - f. Copy of GST Registration/ GST returns Certificate.
 - g. Income Tax return of last three years.

- h. Experience of having successfully completed similar works during last three years from Government organization such as CPWD/PWD/autonomous bodies etc.
- 7. The firms those are registered with MSME/NSIC/Udhyam may also be given exemption in turnover & Experience as per rule.
- 8. No advance payment will be made. However, the payment will be made 100% completion of the work on actual measured quantity basis and acceptance by ICAR-CPRI-RS, Modipuram through NEFT/RTGS/e-Payment within normally 45 days from the date of receipt of Bill for execution the work in good condition as per order. The necessary deductions Viz. Income Tax, GST-TDS, Labour cess, if applicable, and such other taxes levied by government from time to time will be deducted from the work bill.
- 9. The quantity proposed in the quotation may be increased or decreased upto 25% at the discretion of the authority while placing the order.
- 10. Before quoting rates the bidder may visit the premises where work has to be done and ascertain the condition of the premises and fixtures & fittings. Any additional claim after bidding will not be entertained.
- 11. The bidder does not quote rate of any item under schedule of quantities or left the rate column blank then their bid will be treated as unresponsive & shall not be considered.
- 12. The lowest bidder will be finalized based on overall quoted amount in this tender. However, total amount will be considered based on sum of individual items.
- 13. If the Government imposes any new taxes on this concerned nature of work after issuing the work order, then same may be reimbursed to party if they submit the relevant proof of that.
- 14. The agency/firm will have to take all measures at their own cost related to safety of workers during execution of work.
- 15. The workers will be personnel of the tenderer and ICAR-CPRI-RS, Modipuram will have no responsibility whatsoever to them. Any liability that may arise due to death/injury to any of the workers while executing the work will be borne by the tenderer.
- 16. Quotation not found according to specification will be rejected/not considered.
- 17. Form 'C & D' will not be issued. However, the firm is required to produce the valid GST Registration no. The firm should also indicate PAN/TIN as per Income Tax Rules.
- 18. The Rates should be clearly indicated in figure as well as in words. While quoting the rates, it may be clearly indicated whether the items are inclusive or exclusive of all taxes in terms of percentage or in absolute term.
- 19. Works will have to be completed normally within 45 days from the date of issue of work order or as mentioned in the supply order unless such extension is allowed by the Institute failing which suitable penalty as indicated in the work order will be imposed.
- 20. Penalty for delayed Completion of the works: The Head, ICAR-CPRI-RS, Modipuram reserves the right to levy penalty @ of 0.5% of order value per week of delay beyond the scheduled date completion/execution of the order successfully, subject to maximum of 10% of the order value.
- 21. The supplies/related spare parts/items to be fixed shall be in the compliance to the specifications mentioned in Scope of Work of the tender and shall be of the latest technology, best quality and ISO recognized brand and commissioning to the satisfaction of ICAR-CPRI-RS, Modipuram.
- 22. Any optional accessories/tooling, besides the standard equipment recommended for the better performance of the equipment, if offered, is provided with their full technical details including their use and advantage in a separate sheet with the tender documents along with service plan.
- 23. If any damage occurs to ICAR-CPRI-RS, Modipuram property during execution of work including dismantling the same will be borne/ repaired by the tendered. For this reason, the tenderer/bidder is advised to inspect the work site before submitting the tender.

24. In case the agency/firm leaves the work or shows unwillingness to do work within stipulated contract period, suitable action will be taken against the firm and the agency/firm may also be debarred for 2 years for participation any tender in ICAR-CPRI-RS, Modipuram.

25. At any time, prior the deadline for submission of bids. ICAR-CPRI-RS, Modipuram may, for any reason, whether on its own initiative or in response to clarification request by a prospective bidder,

modify the bid document.

26. The Tenderer/bidder will be abiding by the contract labour act, minimum wages act and other labour related acts, applicable during execution of the work.

- 27. In case of any dispute on execution or other issues related to this work, the decision of the Director, ICAR-CPRI, Shimla, will be final and binding on both the party.
- 28. The Head, ICAR-CPRI-RS, Modipuram reserves the right to accept or reject any or all the quotation without assigning any reason.
