OFFICE MEMORANDUM

1. The tender was floated vide office letter No.F.VI12016/Jal/Cleaning/7661 dated 17<sup>th</sup> February, 2020 for general cleanliness and sweeping work at ICAR-CPRS, Jalandhar w.e.f. 01.06.2020 to 31.05.2021.
2. Whereas M/S LB Bonafide Pvt. Ltd., New Delhi have quoted the lowest rate at Rs.6,76,140/- which is less than the rates quoted by the firm for the previous year.
3. Whereas as per Annexure "X" the firm submitted that "I/We agree to keep the offer of this tender valid upto 31.05.2021 from the date of receipt of the tender and not to modify the whole or any part of it for any reason".
4. Whereas a letter was issued vide letter No.F.VI12016/JAL/Cleaning/76 dated 05.05.2020 to know the guinness of the rates in the light of the terms & conditions of the contract.
5. Whereas the firm agreed that due to confusion/hurry to submit the tender, it has mistakenly quoted the financial rates, which affected the whole tendering process.
6. Whereas it is presumed that the firm has denied to accept the contract on its quoted rates.
7. Therefore, for the said act of M/S LB Bonafide Pvt. Ltd., New Delhi, the Competent Authority of the Institute has debarred the said firm for participation in the tendering process carried out by ICAR-CPRI, Shimla and its all Regional Stations for a period of two years from the date of issuance of this memorandum.
8. Accordingly M/S LB Bonafide Pvt. Ltd., New Delhi is hereby debarred.
